Dear Families,

The School City of Hobart has an Online Programming option for the 2022-2023 school year called **Brickie Virtual School (BVS)**. BVS is a school for online learners only. It will provide separate online learning in a class setting for remote students only.

Please know that in-person learning has proven to be most effective for student success. You must know your child and the best scenario for them to thrive in school. If you are interested in learning about an online school for your student, please review the attached BVS Packet to learn about programming.

Brickie Virtual School enrollment for the 2022-2023 school year will be limited and will be contingent on "good cause" to attend virtually. Selection will be based on a completed application, a review of the student's academic standing, attendance, conduct history, and, most importantly, the family's commitment to support the student's academic progression of grade level standards and/or credits as indicated by previous school records. Submitting a BVS application does not guarantee that your student will be accepted into BVS.

*Some secondary classes are only available in-person and require your own transportation.

Applicant families will be required to sign off on reading and agreeing to the SCOH Brickie Virtual School handbook and the following responsibility standards:

- I will monitor my student's academic progress and keep in close communication with teacher(s).
- I commit my student to be placed in Brickie Virtual School for a minimum of one semester.
- I will provide my student transportation to and from school for required in-person testing/activities.
- I will provide access to reliable WIFI daily during school hours for my student.
- I will provide a secure and safe study environment for my student to engage in online instruction.
- My student will be in attendance for the required live remote instruction as deemed necessary by the instructor and/or school.

Please note that only families wanting to enroll students in Brickie Virtual School for online learning need to fill out this Skyward application. If you do not complete a BVS application, your students will be registered into the traditional in-person classroom setting.

- Click on ONLINE FORMS.
- Click FILL OUT FORM next to "Brickie Virtual School Appl." for each student you wish to register for the Brickie Virtual School.

Families interested in Brickie Virtual School (grades K-12) for the 2022-2023 school year must complete an application for each student.

BVS Applications are due by April 29, 2022.

BVS applicants will be notified of program enrollment decisions.
