## **Brickie Virtual School (BVS): An Online Programming Option for School City of Hobart**

Families interested in Brickie Virtual School (grades K-12) for the 2021-2022 school year must complete an application for each student.

**Please note that only families wanting to enroll students in Brickie Virtual School for online learning need to fill out this Skyward application.** If you do not complete a BVS application, your students will be registered into the traditional in-person classroom setting.

- To apply, please log in to your Skyward Family Access account.
- Click on ONLINE FORMS.
- Click FILL OUT FORM next to "Brickie Virtual School Appl." for each student you wish to register for the Brickie Virtual School.

**Brickie Virtual School enrollment for the 2021-2022 school year will be limited and will be contingent on whether there is enough interest to fill a class.** Selection will be based on a completed application, a review of the student's academic standing, attendance, conduct history, and, most importantly, the family's commitment to support the student's academic progression of grade level standards and/or credits as indicated by previous school records. Submitting a BVS application does not guarantee that your student will be accepted into BVS. \*Some secondary classes are only available in-person and require your own transportation.

Applicant families will be required to sign off on reading and agreeing to the SCOH Brickie Virtual School handbook and the following responsibility standards:

- I will monitor my student's academic progress and keep in close communication with teacher(s).
- I commit my student to be placed in Brickie Virtual School for a minimum of one semester.
- I will provide my student transportation to and from school for required in-person testing/activities.
- I will provide access to reliable WIFI daily during school hours for my student.
- I will provide a secure and safe study environment for my student to engage in online instruction.
- My student will be in attendance for the required live remote instruction as deemed necessary by the instructor and/or school.

### **BVS Applications are due by April 28, 2021.**

Brickie Virtual School applicants will be notified of program enrollment decisions by **Monday, May 10, 2021.**
